

2015 Lake Placid Central School Taxes

How do I pay my taxes?

1. By Mail Mail exact amount payments to: Lake Placid Central School, 50 Cummings Rd, Lake Placid, NY 12946

Note : **No partial payments accepted.** Payments are due *in full* and penalty free in September. Payments postmarked between Oct. 1 and Nov 2, 2015 incur a 2% penalty, and a 3% penalty for postmarks of Nov. 3&4, 2015. After Nov 4, 2015, payments mailed to the Lake Placid School District (LPCSD) will be returned. Contact the school tax collector for payment instructions.

2. In Person a. NBT Bank - both Lake Placid locations

Outpost Branch: 1944 Saranac Ave, Lake Placid payments accepted 9am – 3pm

Main Street Branch: 2483 Main Street, Lake Placid payments accepted 9am – 3pm

b. LPCSD Administrative Services Center (annex) Monday – Friday 8am – 3pm

Closed Labor Day and Columbus Day

Please respect the safety of our children loading/unloading buses near the annex on 50 Cummings Road

Remember **traffic is one way up the hill** (behind the middle/high school) from School St. toward ORDA

Parking is very limited and you should expect delays with bus activity throughout the day

LPCSD now accepts electronic check and credit card payments for your school tax bills using our online payment service, **Municipay**. Go to www.InfoTaxOnline.com Scroll down to Lake Placid CSD and locate your tax bill by entering in only your last name (leave other fields blank for better search results) **Please note:** *as the taxpayer, you are responsible for any fees associated with using the online payment service.*

Credit card and electronic checks payments are available online only and are not available by phone or over the counter.

a. **Credit Card Payments: 2.45% Fee, \$3.00 minimum**

Credit cards accepted: MasterCard, Discover, American Express, or Visa.

A per transaction convenience fee of 2.45% or \$3.00 minimum will be charged by the payment processing company for this service.

b. **Electronic Check Payments: \$1.50 charge from MuniPay**

Payments will be charged to your checking or savings account at your bank. You will need your 9-digit routing number as well as your account number from your personal checks (see example below). A per transaction convenience fee of \$1.50 will be charged by the payment processing company for this service. **One parcel is one transaction.**
